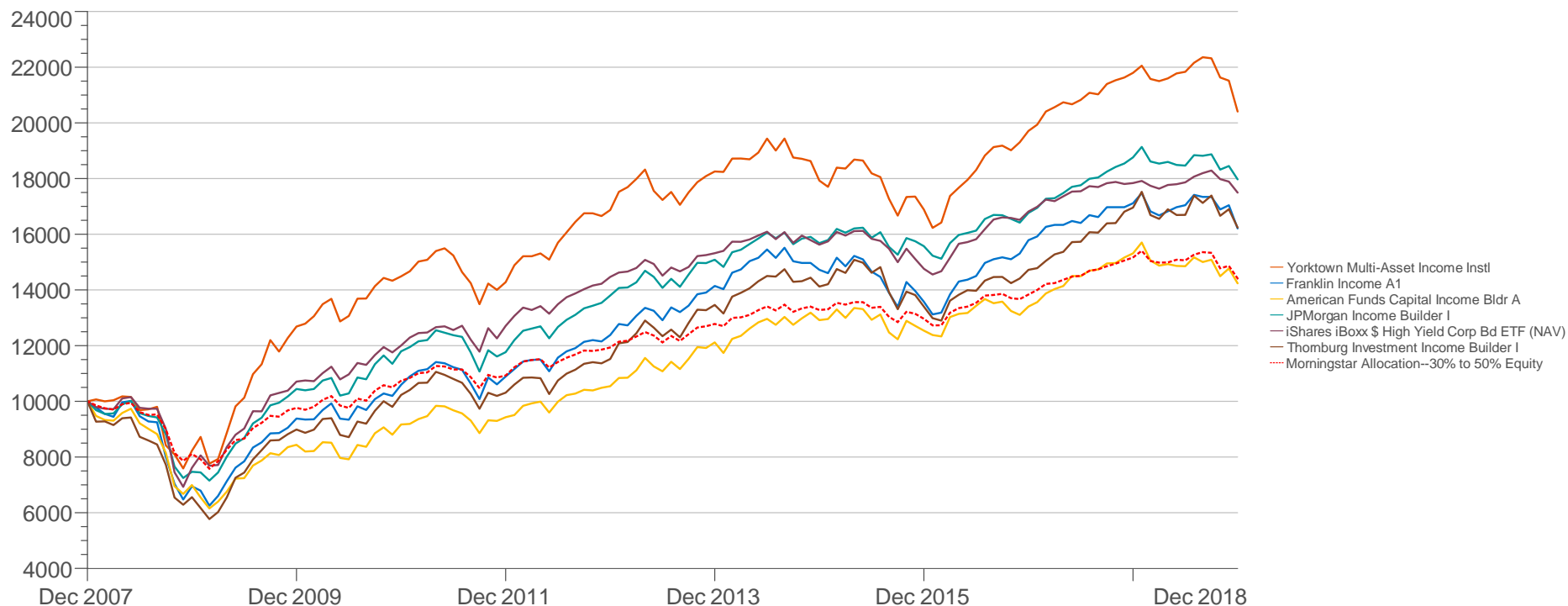

January 2008 - December 2018 (Single Computation)



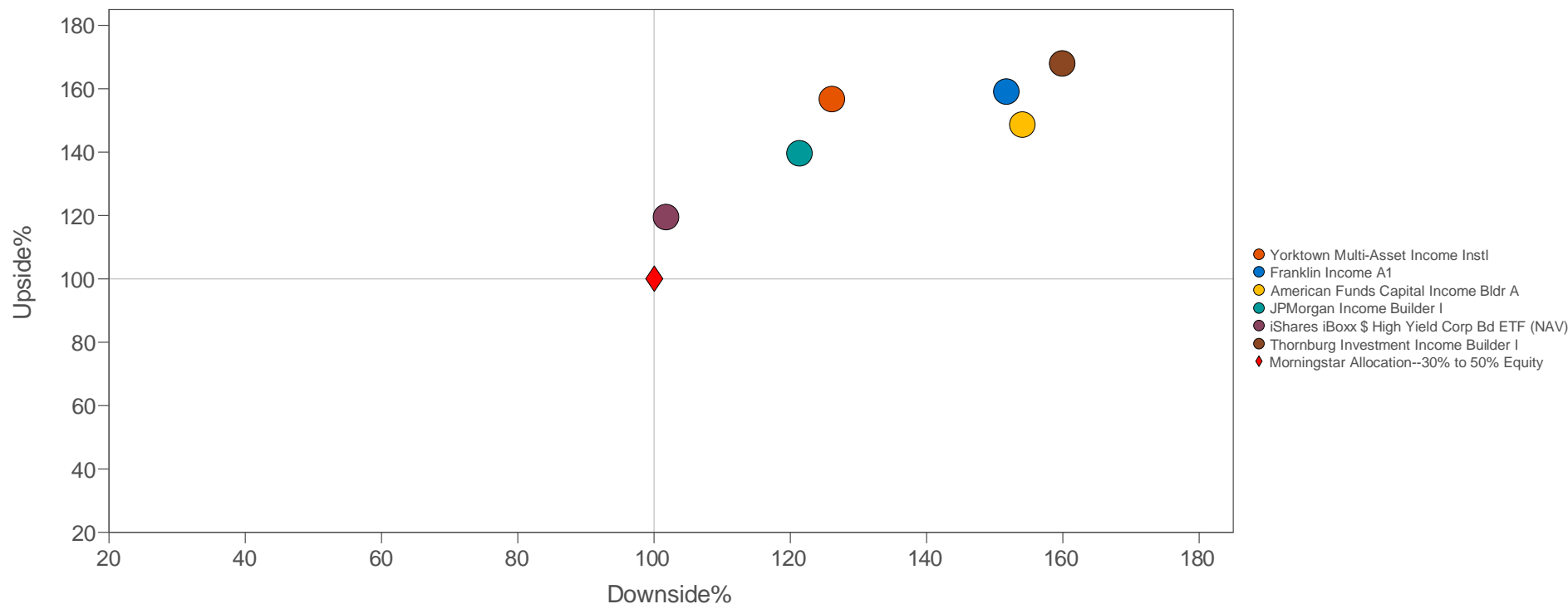

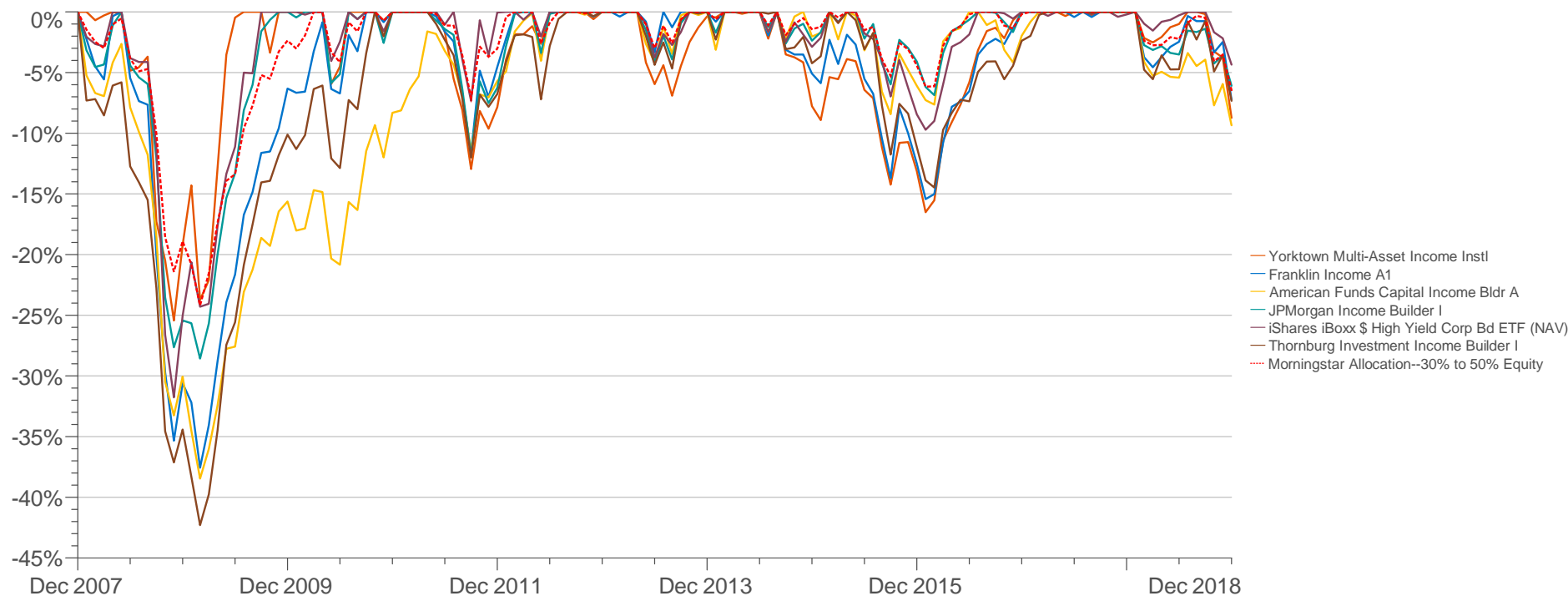
