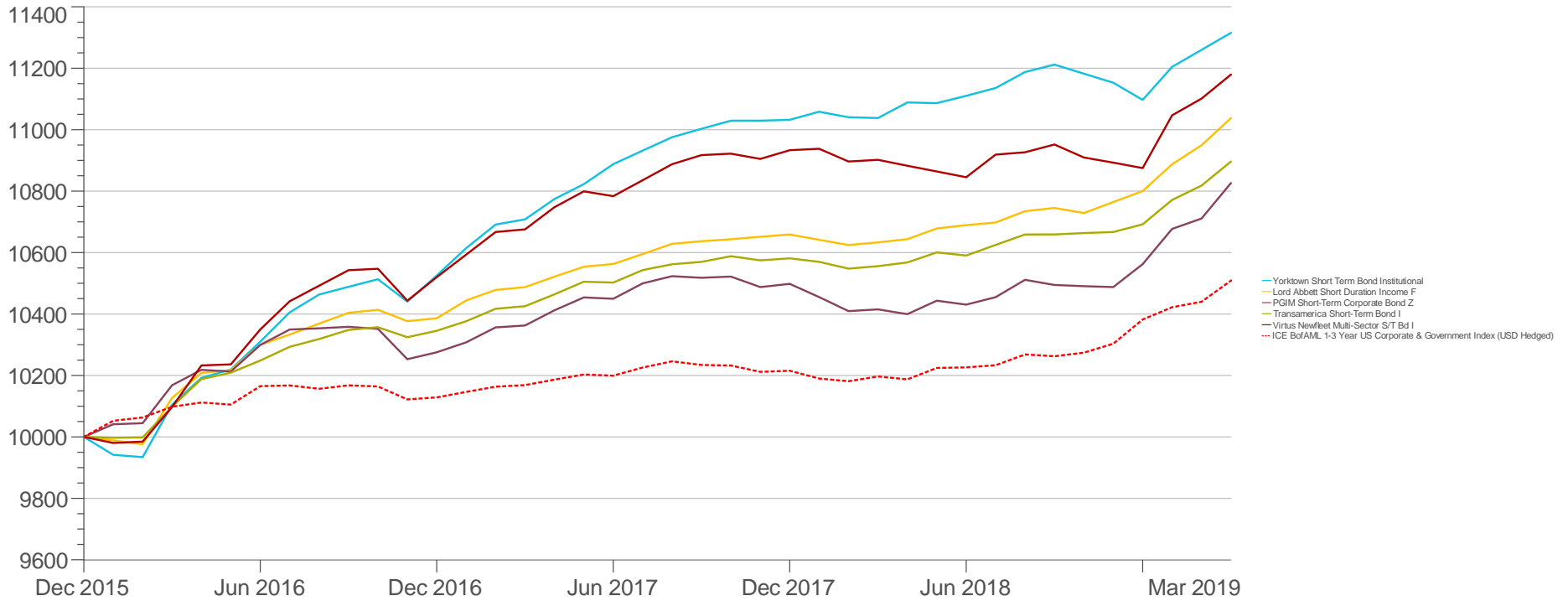

January 2016 - March 2019 (Single Computation)



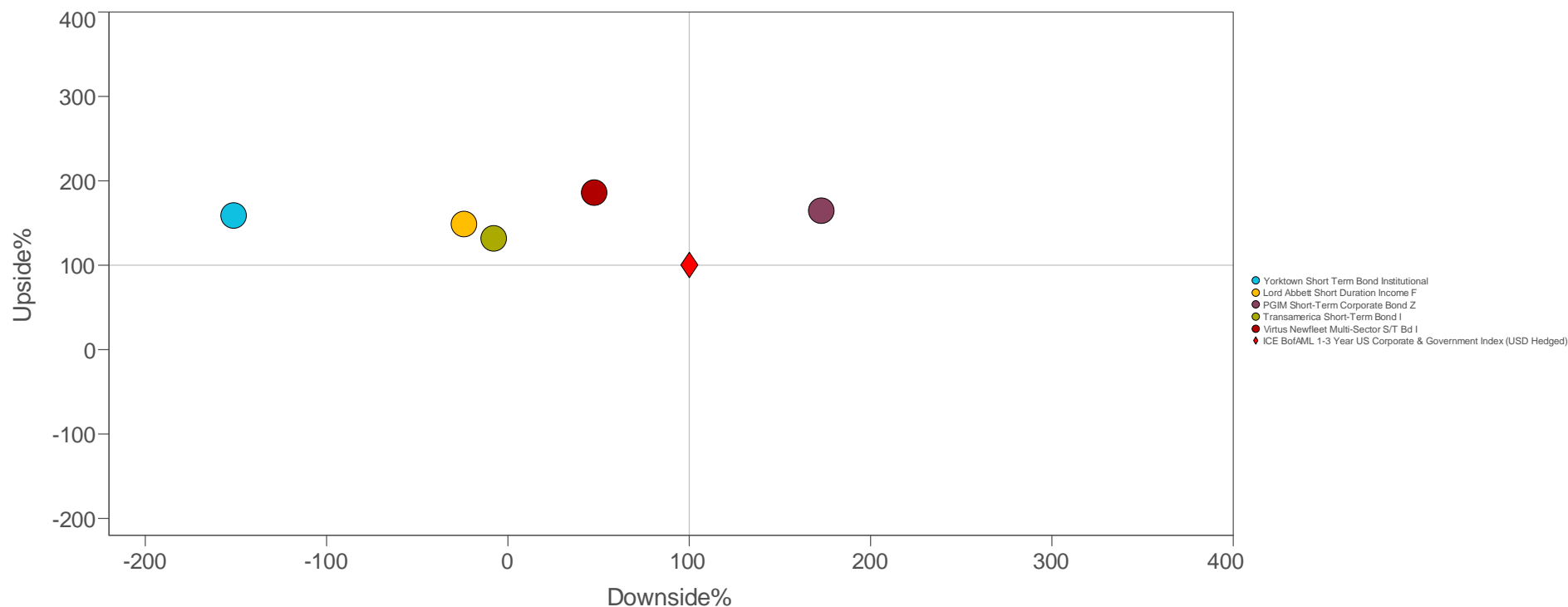

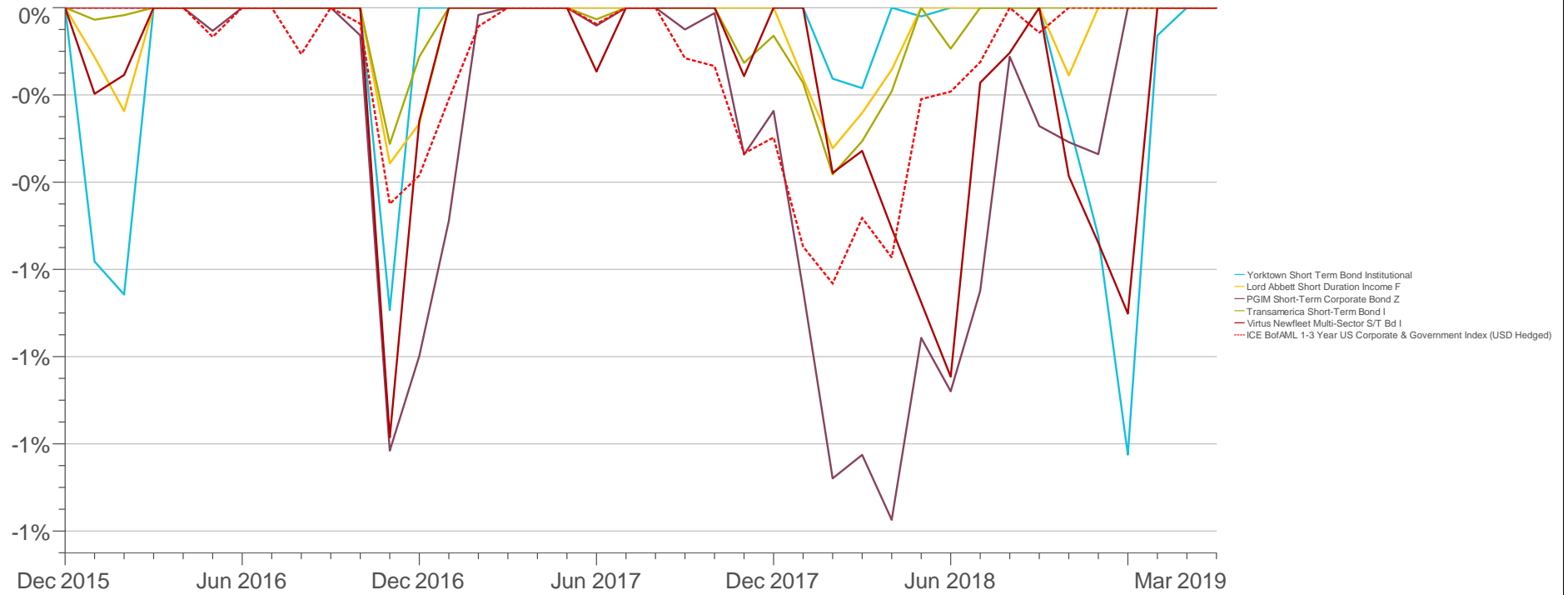

In addition, the Adviser has entered into a one-year contractual expense limitation agreement with the Trust, effective May 31, 2018, so that the Fund's ratio of total annual operating expenses is limited to 0.89% for Class A shares, 1.89% for Class L shares, and 0.89% for Institutional class shares.
