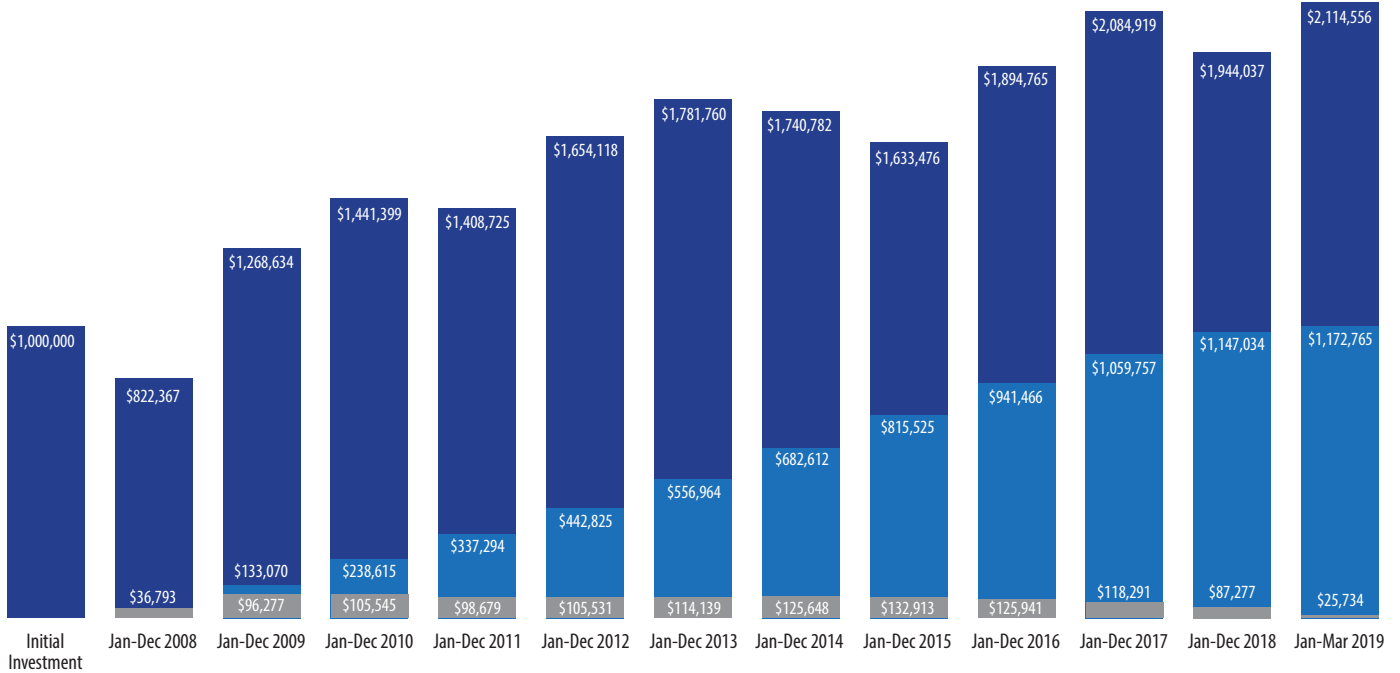

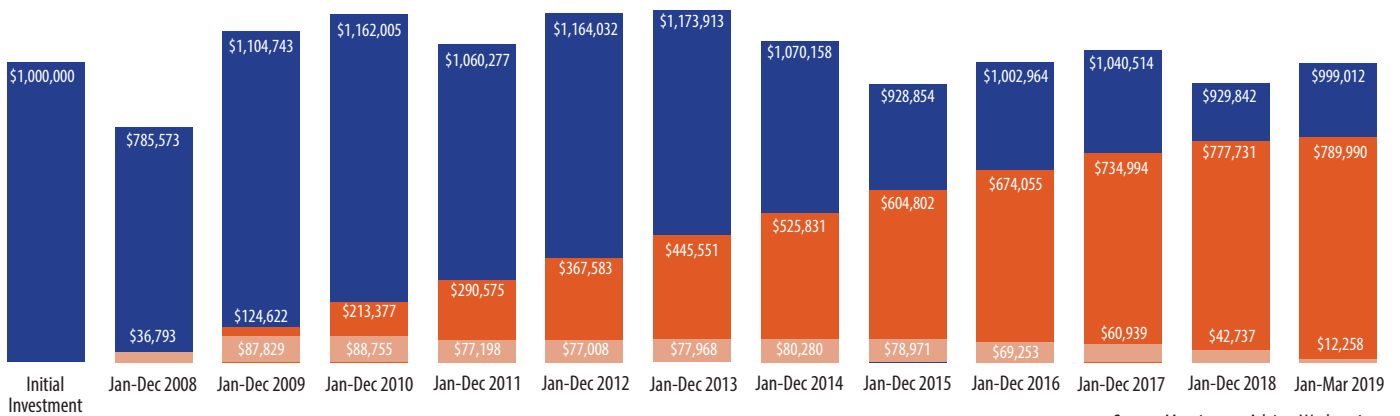
## Enhanced Yield by Reinvesting Dividends
